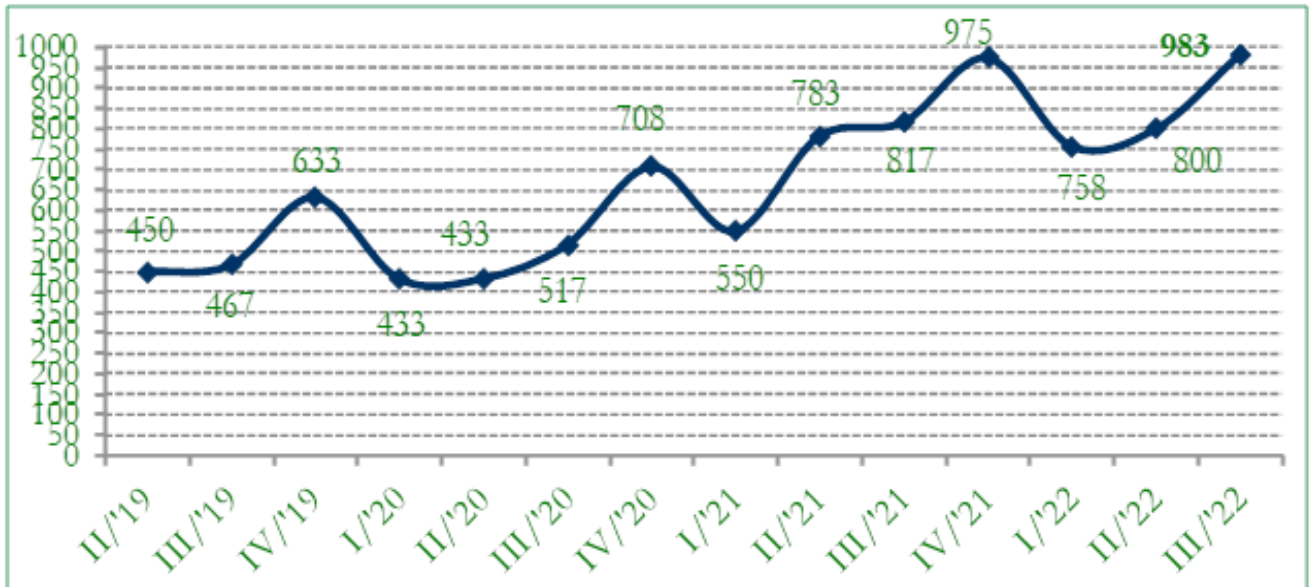


2019-2022: Private Equity Monitor Index – PEM®I (2003 base 100)
